- 2. **Donor Name:** Fill in donor's name, address and phone number. The donor is the person or company/organization actually donating the item. The contact name is the person filling out the form.
- 3. **Address:** To ensure proper acknowledgement, it is very important that the address, zip code and phone number are complete and accurate.
- 4. **Donor Signature:** The Donor Signature line must be signed to verify the "estimated fair market value" amount was provided by the actual donor.
- 5. **Detailed Description:** Describe the item or service fully. Please be as descriptive as possible.
- 6. **Estimated Fair Market Value:** The "estimated fair market value" is the value of the item according to the donor.
- 7. **Tax Information:** If your in-kind donation is valued **over \$500**, you must fill out IRS Form 8283. If the item is valued at **over \$5,000**, you should obtain the signature of a qualified appraiser on their 8283 prior to delivery of the 8283 to San Diego Center for Children for signature. Should you have any questions, please refer to IRS publications 526 "Charitable Contributions" (http://www.irs.gov/publications/p526/index.html) and 561 "Determining the Value of Donated Property" (http://www.irs.gov/publications/p561/index.html) and/or consult your tax advisor. Please note that contributions of services are not deductible as charitable contributions.
